CREDIT TERMS AND CONDITIONS

It will be understood that we will make necessary enquiries not only with the information supplied in Application for Credit but with any bureau, mercantile company or supplier of our choice.

We are not bankers in any sense and there is no automatic right of access to our money in the form of credit, but for customers who have been approved we can facilitate trade by waiting the accepted 30 days for orderly processing of invoices and payments. **TERMS ARE STRICTLY 30 DAYS FROM INVOICE DATE.**

Any delay beyond 30 days due to exceptional circumstances must be discussed and agreed in every instance if collection action is to be avoided. Credit is not extended on a basis that we are paid when you are paid. We give credit to our customer only, not our customer's customer.

In the light of information from time to time we may require a fresh Application or in some circumstances a more comprehensive Supplementary Application to be completed. Credit may be withdrawn at the discretion of Rex Brock Pty Ltd trading as Westminster Printing if terms are exceeded or adverse information becomes known.

All goods sold are subject to Rex Brock Pty Ltd trading as Westminster Printing Credit Terms and Conditions as herein, and also to our general Terms and Conditions of Trading, and these prevail over any conflicting terms and conditions incorporated in standard orders supplied by customers. Any claims against alleged errors or omissions must be advised within 48 hours of receipt, confirmed in writing within 14 days and payment is required for all the undisputed portion.
